Who may apply?

A non-profit or governmental unit that resides in Centerville, SD or the immediately surrounding area.

When can we apply?

The grant is open year round and applications will be considered in a timely manner once received.

What types of projects qualify?

A variety of projects will be considered. All projects must fit within the Centerville Development Corporation's mission. Funding for normal operating expenses are not considered an acceptable project.

Who reviews the applications?

A review committee made up of Centerville Development Corporation board members and community members will review the applications and determine which will be awarded funding for the year. There is a limited amount of funding each year. This means all projects may not be awarded funds or an amount less than requested may be awarded. This is all dependent on the number of applications received and dollars requested in a given year. We anticipate this grant program being available from approximately 2020 to 2023.

When will the awards be announced & the grant dollars given out?

Awards will be announced at the Centerville Development Corporation annual Celebrate Centerville Gala event at the end of the year. Special exceptions for requests for grant dollars to be given out earlier may be considered if your project is time sensitive and needs support prior to the gala.
